Using the CE Scanners and/or an Excel Sheet

There is a downloadable attendance spreadsheet to the CE website. You can find it at Training > Attendance > Attendance Spreadsheet or by using this url: http://ce.calsurv.org/train/ppf/attendance_sheet. This sheet is not necessary to collect attendance, but it will aid in matching up the number scanned from the card with the person's name, agency, and cert status.

To use the sheet to collect attendance, highlight the A2 cell under SIGN IN and start scanning the cards. Excel should scroll down the column as the certification numbers are filled in.

Please Note:

- The system adds a "g" at the end of some card numbers when the cards are scanned in.
 - This is not a huge issue, as MVCAC staff are able to just run a find and replace to eliminate the "g" before uploading the ID numbers to the course.
 - Once the "g" is eliminated, the attendee's information (associated with their card number) is displayed within the spreadsheet.
- Some cards have trouble reading on the scanner or pull up the wrong numbers all together. This is more than likely an issue from the barcode not being correct or from the card being worn down being a wallet, etc.
 - Solution: Always have the person scanning attendee cards quickly verify the number displaying within the spreadsheet is accurate. If not, the attendee (or person scanning cards) can manually type in the ID number of the attendee and their information from the database should pop-up.

Using Handwritten Sign-In Sheets

- Download the blank sign-in sheet from the MVCAC website:

- Fill in all necessary course information: Program title, number, date, etc.
